Programme Beneficiaries

The programme draws on many years of experience in strengthening the knowledge and skills of middle- and senior-level officials from around the world. The primary beneficiaries include: Government and Ministry officials; Central Bank staff; Finance and trade officials; Staff of financial regulatory and trade bodies; Academics; Legal professionals from the public and private sectors; and NGO and civil society representatives.

Since 2003, over 330 training events have been developed and delivered which benefited more than 15,000 finance and trade officials from over 140 countries around the world. The average completion rate is 87%, with around 40% of beneficiaries being female. Based on surveys conducted after every training event, the overall satisfaction rate of participants was 92%.
